Reclassification Extended Testing Window

Fall 2021

Background

- Reclassification testing which takes place in late spring each year. Schools assess students with the lowa
 Assessments for grades 1, 2 11, and 12 to exit EL programs.
- Students are required to score =>40 NPR in both Reading and Language (Grades 1 and 2) or both Reading and Written Expression (Grades 11 and 12) to exit EL.
- Due to COVID-19, TEA has extended Reclassification testing through the first 60 days in Fall 2021.

Three Fall 2021 Reclassification Testing Scenarios

- 1) <u>Tested Paper/Pencil in Spring</u> <u>No changes</u> You will test any student in Fall as if they tested in Spring
- 2) <u>Tested Online in Spring.</u>—You will <u>Reopen</u> the Spring Test Event and test the student at the same grade as if testing in Spring. For example, I am testing a current third grader who was a second grader in Spring. The student would take Grade 2 test (lows Survey Level 8).
- Did not test in Spring, Testing Online in Fall You need to create a New "Reclass Roster File 2021" and New "Reclass Fall 2021" test event with Test Event Date of July 31, 2021. This must be created by Aug 30!

Scenario 1: Fall 2021 Paper/Pencil Testing Instructions

- 1) Tested Paper/Pencil in Spring No changes You will test students in Fall as if they tested in Spring 2021.
- 2) Use the same level test books, answer documents, answer keys and Spring Norms.
 - a. Current (Fall 2021) Grade 2 = Iowa Survey Level 7 (Spring 2021 Grade 1)
 - b. Current (Fall 2021) Grade 3 = Iowa Survey Level 8 (Spring 2021 Grade 2)
 - c. Current (Fall 2021) Grade 12 Iowa Complete Level 17/18 (Spring 2021 Grade 11)

Scenario 2: Fall 2021 Tested Online in Spring Instructions


- 1) Reopen Spring 2021 Test Event
- Add any students to the Spring 2021 Roster. IMPORTANT When adding students, make sure to use the grade they were in the Spring 2021 and Spring norms.
 - a. Current (Fall 2021) Grade 2 = Iowa Survey Level 7 (Spring 2021 Grade 1)
 - b. Current (Fall 2021) Grade 3 = Iowa Survey Level 8 (Spring 2021 Grade 2)
 - c. Current (Fall 2021) Grade 12 Iowa Complete Level 17/18 (Spring 2021 Grade 11)
- 3) You will need to reopen the test event in 30 days if you have not completed all testing.



- 1. Paper/Pencil No changes You will test any student in Fall as if they tested in Spring 2021
- 2. <u>Tested Online in Spring</u> You will Reopen the Spring Test Event and test the student at the same grade as if testing in Spring.
 - a) For example, I am testing a current third grader who was a second grader in Spring. The student would take Grade 2 test (Iowa Survey Level 8).
- 3. <u>Did not test in Spring, Testing Online in Fall</u> You need to create a New "Reclass Roster File 2021" and New "Reclass Fall 2021" test event with Test Event Date of July 31, 2021. This must be created ASAP!!

English Learner Reclassification: FAQ's

- 1. If testing paper/pencil, are there any changes to the administration process for Fall 2021 testing? No
- 2. When does the testing window close for Reclassification in Fall 2021? November 1, 2021
- 3. How long will my district have access to the TXRTA? If purchased before July 1, 2021, you will have access until Nov. 1, 2021, and will be required to submit another order to access in Spring 2022.
- 4. Is training required? New user = Required; Returning user = Refresher Strongly Recommended every 2-3 years
- 5. How do I reopen a test event?
