# Plan Sold in Tuition Units

Tuition units represent a fixed amount of undergraduate resident tuition and schoolwide required fees charged at Texas public colleges and universities, excluding medical and dental schools.



- Texas public colleges and universities must accept the tuition units as payment in full for undergraduate resident tuition and schoolwide required fees for the number of hours covered by the units.

## Use Transfer Value of Tuition Units at:

- ✓ Medical or dental schools
- ✓ Texas private colleges and universities
- ✓ Career schools
- ✓ Out-of-state colleges and universities
- ✓ Registered apprenticeship programs

• Transfer Value is limited to the lesser of the costs your tuition units would cover at a Texas public college or university, or the amount paid for the tuition units, plus or minus the plan's net earnings or losses on that amount.

## Type II

Based on the weighted average cost of all Texas public 4-year colleges and universities.

**\$115.89/tuition unit\***

## Type III

Based on the weighted average cost of all Texas 2-year colleges.

**\$32.15/tuition unit\***

- ✓ A tuition unit is equal to 1% of an academic year or 30-semester credit hours at the Texas public college or university that most closely matches the pricing index for the tuition unit.
- ✓ Purchase up to the dollar equivalent of **600 Type I tuition units**.
- ✓ Any type of tuition unit can be used at any eligible school -- how many units needed will depend on the type of tuition units purchased, the school attended, and the number of credit hours enrolled.




# Redemption Value of 100 Tuition Units\*





# Three-Year Holding Period

- A beneficiary may not use tuition units earlier than the third anniversary of the date the **tuition unit** was purchased.
- The purchase date is determined by the **first payment due date** for **tuition units** purchased under any payment plan.

First payment due date is May 1<sup>st</sup> after the end of the general enrollment period.

First payment due date for beneficiaries added during newborn enrollment will be approximately 90 days following enrollment.

- ✓ For subsequent **Pay-As-You-Go plan** tuition unit purchases, the purchase date is the payment receipt date for such purchase.



## Compare types of aid

With so many different financial aid options out there, you might be wondering through each type of financial aid and explain their differences. We'll even opportunities.

Some types of aid are based on financial need, and some on academic performance. Most participate in all programs, but the more you know about financial aid, the better you'll be able to take advantage of all the opportunities available to you.

### Why should you care about applying for financial aid?

When you submit a financial aid application, it opens the door to many types of financial aid that can help pay for your education after high school, but you must apply to receive them.

In Texas, all high school seniors are required to submit a financial aid application. Every year, billions of financial aid dollars go unclaimed by students, simply because they don't know about them. By applying for financial aid, you can help more students to get money to help pay for college or training after high school.

### What financial aid is out there?

#### Grants

Grants are considered "free money" that you don't have to pay back. Grants are usually based on your financial need. You can get these from the government or from your college.

[Texas Higher Education Coordinating Board](#) has a list of federal and state grants and scholarships. In Texas, some colleges offer grants that cover your full tuition and living expenses.

#### Scholarships

Scholarships are a great way to get free money for your education that you don't have to pay back. It's important to start your scholarship search early—many opportunities begin before your senior year. While you're exploring options, consider the Texas First Program. If you're eligible to graduate high school early through this program's requirements, you're also eligible for a scholarship. Be sure to talk to your school counselor to learn if this program is right for you and how to apply.

#### Student loans

Student loans are money you borrow to pay for your education or educational expenses. After graduating or ending your program of study, you'll have to pay back the money you borrowed, plus any interest accrued.

Loans from the federal government usually have much better interest rates and loan terms than what you can get from a private bank or credit union.

When can you apply for financial aid?

Applications open October 1 every year. This is the earliest you can apply to receive aid during the upcoming school year. Financial aid is offered on a first-come, first-served basis. So, try to file as soon as possible after October 1.

Two major financial aid deadlines to mark in your calendar

**State Priority Deadline**  
January 15 – In Texas, this is the state priority deadline of the current academic year.

**Federal Deadline**  
June 30 – The federal filing deadline and absolute last day to send your financial aid application is June 30 of the school year you're requesting aid.

**Tip:** The sooner you apply, the better your chances of getting aid. Money is limited, and colleges can run out of funding.

Are you a dependent or independent student?

If you meet one or more of the following criteria, then you are an independent student and will only use your own income and tax information:

- 24 years old or older
- Married
- Enrolled in a graduate level program (master's or doctorate)
- Have children or other dependents who receive more than half of their support from you
- Active duty in the U.S. military or a veteran
- Both parents are deceased, or you were in foster care or a ward of the court
- An emancipated minor or in a legal guardianship
- An unaccompanied youth who is homeless or at risk of being homeless

If you don't meet the above criteria, then you are a dependent student.

You will need to use your own income and tax information, plus information about your parents.
